

**CBD Veggie Capsule (15mg)****DESCRIPTION**

HempFlax's CBD capsule is made of a decarboxylated supercritical CO<sub>2</sub> extract of industrial hemp leaves from varieties registered on the EU list, mixed with cold pressed organic hemp seed oil. This product is then encapsulated in a vegan, delayed release capsule. Each capsule contains approximately 520mg of oil including 15mg of CBD. This product is a food supplement.
